

## **STATEMENT OF REASONS FOR PROPOSING**

### **WELWYN HATFIELD BOROUGH COUNCIL**

#### **THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, PEARTREE, WELWYN GARDEN CITY) (RESTRICTION OF WAITING, LOADING BAY AND PERMIT PARKING ZONES) ORDER (2) 202X**

Welwyn Hatfield Borough Council (pursuant to arrangement made with Hertfordshire County Council) proposes to introduce waiting restrictions in **Various Roads, Peartree, Welwyn Garden City** under the Road Traffic Regulation Act 1984 (as amended).

The general effect of the Order would be to introduce parking restrictions in the following roads:

#### **Resident only permits zones**

Zone A20 Monday to Friday 9am to 5pm  
In parts of Peartree Lane, Ravenfield Road.

Zone A21 Monday to Friday 9am to 5pm  
In parts of Peartree Lane, Pondcroft, The Spinney, Well Garth.

#### **Double Yellow Lines in parts of:**

Barnard Green, Barnfield Road, Bassingburn Walk, Bedwell Close, Beechfield Road, Bessemer Road, Bridge Road, Bridge Road East, Broadwater Road, Burgundy Croft, Cole Green Lane, Cranborne Gardens, Duncan Close, Essendon Gardens, Ethelred Close, Furzefield Road, Gainswood, Heronswood Place, Heronswood Road, Holwell Road, Home Meadow, Hyde Way, Knella Green, Knella Road, Longlands Road, Longmore Gardens, Ludwick Way, Martinfield, Mill Green Road, Moss Green, Oaktree Garth, Peartree Court, Peartree Lane, Pinewood, Pondcroft, Ravenfield Road, Rosemoor Close, Salisbury Gardens, Salisbury Road, Sandpit Road, Shortlands Green, St Audreys Green, Swallow End, Swallowfields, The Spinney, Verulam Close, Well Garth, Woodfield Road, Woodhall Court and Woodhall Lane.

#### **Loading bay – loading only at all times in parts of:**

Peartree Lane

It is intended that these measures will:

- **Increase the available provision of parking for residents**
- **Reduce instances of inappropriate or inconsiderate parking**
- **Reduce congestion**
- **Improve road safety**

The proposals have been developed following a consultation with residents, Borough and County Councillors, Hertfordshire County Council, Hertfordshire Constabulary and all other statutory consultees, taking into account the duties of Section 122 of Road Traffic Regulation Act 1984.
