(OFF-STREET PARKING PLACES) ORDER 2023 (AMENDMENT NO.1) ORDER 2025**

The Welwyn Hatfield Borough Council (hereinafter referred to as "the Council") pursuant to arrangements made with Hertfordshire County Council ("the County Council") under Section 19 of the Local Government Act 2000 and the Local Authorities (Arrangements for the Discharge of Functions) (England) Regulations 2000 in exercise of the powers conferred on the said County Council by Sections 32, 33, 34, 35, 44, 45, 46, 47, 49 and 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 ("the Act of 1984") (as amended by the Road Traffic Regulation (Parking) Act 1986) and Section 43 and Schedule 3 of the Road Traffic Act 1991 and the provisions of Part 6 of the Traffic Management Act 2004 and all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 of the Act of 1984, hereby make the following Order:

Commencement

- 1) This Order shall come into operation on **Tuesday 1 April 2025** and may be cited as **The Borough of Welwyn Hatfield (Various Car Parks, Hatfield) (Off-Street Parking Places) Order 2023 (Amendment No.1) Order 2025** herein after referred to as "this Order".

Interpretation

- 2) The following Order herein after referred to as "The Amended Order" shall be amended:

- 3) The Amendments are as follows:

Insert at end of Article 27 of The Amended Order:

(h) Any vehicle parked in a disabled parking bay shall be subject to parking charges and maximum stay as specified in Schedule 4 of this Order, and exempted from displaying a parking ticket for a parking period up to 4 hours provided that a disabled persons badge and parking disc set upon the time of arrival and clearly displayed in the relevant position.

- 4) The prohibitions and restrictions imposed by this Order shall be in addition to and not in derogation of any restriction or requirement imposed by any regulations made or having effect as if made under the Act of 1984 or by or under any other enactment.
- 5) The Interpretation Act 1978 shall apply for the interpretation of this Order as it applies for the interpretation of an act of parliament.

## **STATEMENT OF REASONS FOR PROPOSING**

WELWYN HATFIELD BOROUGH COUNCIL

### **THE BOROUGH OF WELWYN HATFIELD (VARIOUS CAR PARKS, HATFIELD) (OFF-STREET PARKING PLACES) ORDER 2023 (AMENDMENT NO.1) ORDER 2025**

Welwyn Hatfield Borough Council is proposing to amend Traffic Regulation Orders in relation to off street car parking in **Kennelwood Lane Car Park, Hatfield.**

The Council are seeking to provide a 4 hour maximum free parking period for disabled badge holders when parking in a pay and display car park displaying a valid disabled person's badge and disc, and provision to pay beyond 4 hours between 7am and 9pm.

Having considered the duty imposed by Section 122 Road Traffic Regulation Act 1984, Welwyn Hatfield Borough Council consider that it is necessary and expedient to make Orders for the following reasons:-

- **For the purposes of relieving or preventing congestion of traffic.**
- **To provide suitable parking facilities**

The proposal has been subject to consultation with local and county councillors representing the area, Hertfordshire Police, Ambulance, Fire and Rescue Services, Officers from Hertfordshire County Council, local residents and businesses.
