#### **WELWYN HATFIELD BOROUGH COUNCIL**

# THE BOROUGH OF WELWYN HATFIELD (VARIOUS ROADS, SHERRARDS, WELWYN GARDEN CITY) (RESTRICTION OF WAITING AND PERMIT PARKING ZONES) ORDER 2025

Welwyn Hatfield Borough Council is proposing to introduce resident permit parking zones and waiting restrictions in **Various Roads, Sherrards, Welwyn Garden City** 

Residents in the roads listed were consulted on proposed restrictions to address existing problems. Residents expressed concerns about local worker, student and shopper parking causing congestion; and vehicles parked too close to junctions.

The proposed restrictions are as follows:

## Double yellow lines (No waiting at any time), affecting parts of

Ashley Close, Brooms Close, Cherry Croft, Coneydale, Crossway, Densley Close, Digswell Park Road, Digswell Road, Fern Grove, Great Dell, Greenfield, Harwood Close, Harwood Hill, Haymeads, Kirklands, Knightsfield, Little Dell, Mandeville Rise, Monks Rise, Monkswood, Nut Grove, Oakdale, Pentley Close, Pentley Park, Pitsfield, Rayfield, Reddings, Roundwood Drive, Scholars Mews, Sherrardspark Road, Shoplands, Stonemead, Summer Dale, Templewood, The Firs, The Glade, The Lawns, Tilecroft, Uplands, Warren Dale, Willow Grove and Woodland Rise.

## Permit parking, Monday - Friday, 9am - 3pm, permit holders only for Zone A18, affecting parts of

Densley Close, Reddings, Roundwood Drive and Sherrardspark Road.

Having considered the duty imposed by Section 122 Road Traffic Regulation Act 1984, Welwyn Hatfield Borough Council consider that it is necessary and expedient to make an Order for the following reasons:-

- For the purposes of relieving or preventing congestion of traffic.
- For the avoidance of danger to persons or other traffic using the road and preventing the likelihood of any such danger arising.
- For preserving or improving the amenities of the area through which the road runs.

The proposal has been subject to consultation with local and county councillors representing the area, Hertfordshire Police, Ambulance, Fire and Rescue Services, Officers from Hertfordshire County Council, local residents and businesses.
