## **Parking restriction formal proposals**

Dear Occupier,

A parking survey and feedback has been conducted in your area between February 2024 and November 2024 has been now concluded and this letter is to advise you that following parking restrictions will be formally proposed in the area on Wednesday 12 March 2025. At this stage, a decision has not been made to introduce restrictions, this is part of the formal stage of consultation. If you wish to formally object to the proposals, this is the time to do so.

### **Double Yellow Lines**

The proposal to introduce double yellow lines on junctions and some short sections elsewhere in some roads to improve access.

## **Verge and Footway Prohibition Order (VFPO)**

The proposal is to introduce a prohibition of parking on public verges, footways, and vehicle crossovers on Highway land.

We have also come to an agreement with Sanctuary Housing to propose the above parking restrictions off the highway in Kilworth Close to prevent obstructive parking.

The public notice of these proposals will be advertised in the Welwyn Hatfield Times on Wednesday 12 March 2025, and public notices will also be placed on lamp columns in the affected roads.

Formal objections to the proposals can be made using the details in the public notice published in the newspaper and on our “Howlands North” webpage [www.welhat.gov.uk/parking-consultations](http://www.welhat.gov.uk/parking-consultations). On the webpage, detailed maps can also be viewed to see the exact locations of any double yellow lines and verge/footway prohibition.

Any comments/objections to the proposed parking restrictions need to be submitted in writing as per instructions on the public notice by Thursday 3 April 2025, so they can be considered by Parking Services and CPPP (Cabinet Planning and Parking Panel).

### **Next Steps**

Any written objections received would be considered at a future meeting of CPPP, where a decision upon if to introduce these restrictions would be made. Further updates relating to this consultation will also appear on the Howlands North webpage, as well as details of any meeting these proposals may be considered at.
